I/We UNDERSTAND that payments may take up to 5 business days to reach the vendor and that they will be sent either electronically or by check. Central Bank is not liable for any service fees or late charges levied against me/us.

I/We UNDERSTAND that I/we am/are responsible for any loss or penalty that I/we may incur due to lack of sufficient funds or other conditions that may prevent the withdrawal of funds from my/our account.

By signing below, I/we agree to these terms, and the terms of the Business Web Banking Electronic Services Agreement that has been provided to me/us by Central Bank.

To qualify for Business Web Bill Pay, you must have a Central Bank business checking account, and you must be a Business Web Banking user.
